EDLE COHORT FINANCIAL AID REGISTRATION PROCESS

Cohort students who plan to use financial aid must notify the EDLE Office of their intent so they may be pre-registered prior to payment being received. Our office requires a few items from you to ensure you understand the process and deadlines.

Summer Financial Aid Enrollment due dates:

- Enrollment request and supporting documentation due May 4, 2020
 - This includes Mason MarketPlace request outlined in this document
 - And a copy of your Financial Aid award notice from Patriot Web
- Payment due upon receipt of funds and no later than June 5, 2020

Fall Financial Aid Enrollment due dates:

- Enrollment request and supporting documentation due August 24, 2020
 - This includes Mason MarketPlace request outlined in this document
 - And a copy of your Financial Aid award notice from Patriot Web
- Payment due upon receipt of funds and no later than September 9, 2020

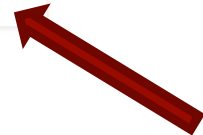

Refund Policy Agreement

CEHD - Education Leadership Cohort Courses

Deposit: (Example) The deposit will be applied toward first course tuition. To receive a full refund a written request must be sent to the EDLE Program by the set deadline.

The deadline for deposit refund can be found on the deposit contract.

Tuition: (Example) All tuition refund requests must be sent to the EDLE Program by the set deadline.

Cohort Tuition refund deadlines for Fall and Spring:

Final drop with **no tuition penalty will be on the 14th day** from the start of the EDLE cohort semester. The cohort deposit will be forfeited if after the cohort drop deadline.

Selective withdrawal from the course on or after the **the 15th day** will result in 100% liability.
