



EDLE COHORT PAYMENT PROCESS FOR THOSE USING FINANCIAL AID

Registered as a student using financial aid? Review the payment instructions enclosed here for a smooth process.



Cohort students who register using financial aid must pay cohort tuition to the EDLE Office through Mason MarketPlace once they receive their financial aid disbursement. Cohort tuition is not paid through student accounts. Detailed procedures are included in this guide.

Payment deadlines:

- Payment is due upon receipt of financial aid funds
 - Funds are disbursed around the first week of campus classes
 - You are strongly encouraged to set up [Direct Deposit](#) to expedite the receipt of your funds
 - Summer Payment is due no later than June 5, 2020
 - Fall Payment is due no later than September 9, 2020

- Late fees will be applied if deadlines are missed

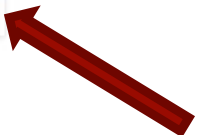

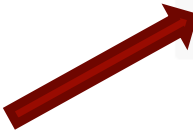

Refund Policy Agreement

CEHD - Education Leadership Cohort Courses

Deposit: (Example) The deposit will be applied toward first course tuition. To receive a full refund a written request must be sent to the EDLE Program by the set deadline.

Tuition: (Example) All tuition refund requests must be sent to the EDLE Program by the set deadline.

Cohort Tuition refund deadlines for Fall and Spring:

Final drop with **no tuition penalty will be on the 14th day** from the start of the EDLE cohort semester. The cohort deposit will be forfeited if after the cohort drop deadline.

Selective withdrawal from the course on or after the **the 15th day** will result in 100% liability.

Students who miss the deadline to selectively withdraw from a course can only withdraw from a course for non academic reasons. Go to [CEHD Withdraw](#) for more information.
