# **Course Description**

Introduction to educational issues not applicable in graduate-level teacher education programs. Examines human development through life span with special emphasis on cognitive, language, physical, social, and emotional development of children. Emphasizes contemporary theories of human development and their relevance to educational practice.

Requires school-based field experience during course.

# **Nature of Course Delivery**

This course utilizes a distributed learning format requiring timely and active participation of all students throughout the semester. Activities to support student achievement of the learner outcomes include instructor presentations, videos, student team presentations, collaborative student work in small groups in class and in on-line discussion groups, assigned readings, and projects leading to written products. Students engage in timely critical reflection and accountable talk related to the learning activities.

#### **Learner Outcomes**

This course is designed to enable students to do the following:

- 1. Discuss the developmental stages of human development in terms of the cognitive, affective, and psychomotor domains and understand the key theories.
- 2. Examine and explain the contributions of heredity, environment, and child rearing practices to the total development of the child.
- 3. Understand the development, and/or, the application of theories as they apply to the instruction of children and adults.
- 4. Explain how people learn through active exploration and multiple interactions with materials, other people, and the adults or leaders in their environment.
- 5. Demonstrate knowledge of contemporary theories of human development and their relevance to educational practices in early childhood, middle, and adolescent education.

## **Course Requirements**

# **General Requirements**

- 1. The completion of all readings assigned for the course is assumed. Because the class will be structured around discussion and small group activities, it is imperative that students keep up with the readings and participate in class and on-line.
- 2. Attendance in class is important to students' learning; therefore, students are expected to make every effort to attend class sessions. Absences, tardiness, and leaving early may negatively affect course grades. If, due to an emergency, students will not be in class, they must call the instructor and leave a message or send an email before class. The following policy is from the university course catalog:
  - Students are expected to attend the class periods of the courses for which they register. In-class participation is important not only to the individual student, but also to the class as a whole. Because class participation may be a factor in grading, instructors may use absence, tardiness, or early departure as de facto evidence of nonparticipation. Students who miss an exam with an acceptable excuse may be penalized according to the individual instructor's grading policy, as stated in the course syllabus.
- 3. In line with Mason's policy that students should not be penalized because of observances of their religious holidays, students shall be given an opportunity to make up, within a reasonable time, any academic assignment that is missed due to individual participation in religious observances. It is the student's responsibility to inform the instructor of any intended absences for religious observations in advance of the class that will be missed. Notice should be provided in writing as soon as possible.
- 4. During face-to-face meetings, cell phones, pagers, and other communicative devices are not allowed in this class. Students must keep them stowed away and out of sight. Laptops or tablets (e.g., iPads) may be permitted for the purpose of taking notes only, but students must submit a request in writing to do so. Engaging in activities not related to the course (e.g. gaming, email, chat, etc.) will result in a significant deduction in their participation grade.

5. It is expected that assignments will be turned in on time (the beginning of the class in which they are due). However, it is recognized that students occasionally have serious problems that prevent work completion. If such a dilemma arises, students should speak to the instructor prior to the assignment due date (when possible). If the student does not communicate with the instructor, a late penalty will be applied.

6. Mason is an Honor Code university; please see the Office for Academic Integrity for a full description of the code and the honor committee process. The principle of academic integrity is taken very seriously and violations are treated gravely. What does academic integrity mean in this course? Essentially this: when responsible for a task, students will perform that task. When students rely on someone else's work in an aspect of the performance of that task, they will give full credit in the proper, accepted form. Another aspect of academic integrity is the free play of ideas. Vigorous discussion and debate are encouraged in this course, with the firm expectation that all aspects of the class will be conducted with civility and respect for differing ideas, perspectives, and traditions. When in doubt (of any kind), students will ask for guidance and clarification.

# **Written Assignments**

All written assignments prepared outside of class will be evaluated for content <u>and</u> presentation. The American Psychological Association, Sixth Edition (APA) style will be followed for all written work. All written work unless otherwise noted must be completed on a word processor and should be proofread carefully. (Use spell check!) If students are not confident of their own ability to catch errors, they should have another person proofread their work. When in doubt, they should check the APA manual. Portions of the APA manual appear at the Style Manuals link on the Mason library web guide at <a href="http://infoguides.gmu.edu/style">http://infoguides.gmu.edu/style</a>. Students may consult the Writing Center for additional writing support.

Students will do the following:

- 1. Present ideas in a clear, concise, and organized manner. (Avoid wordiness and redundancy.)
- 2. Develop points coherently, definitively, and thoroughly.
- 3. Refer to appropriate authorities, studies, and examples to document where appropriate. (Avoid meaningless generalizations, unwarranted assumptions, and unsupported opinions.)
- 4. Use correct capitalization, punctuation, spelling, and grammar.

# **Attendance and Participation (15 points)**

Because active participation and engagement are imperative for optimal learning, preparation for and participation in in-class activities will be evaluated based on the following criteria:

- Students attend class, arrive on time, and stay for the entire class period.
- Students complete readings and prepare for class activities prior to class as is evidenced by their ability to discuss and write about the concepts presented and examined in the texts as well as participate fully in related activities.
- Students are actively involved in in-class and online learning experiences as is evidenced by (1) participating in all activities, (2) engaging in small and large group discussions, (3) not using laptops and other electronic devices during class time except as approved to support learning within the current class activity, (4) completing written work related to the activities, and (5) supporting the participation and learning of classmates on-line and face-to face.
- Students show evidence of critical reflective thinking through in-class and online discussions, activities, and written reflections.

#### **Journal Entries**

# Due: September 11, October 2, October 23, November 13

Students are responsible for writing four (4) journal entries that reflect deeper thinking on the class material and class discussion. Students may choose any topic that has been discussed or covered in class, as well as the text. They will reflect on the class readings and discussions and include your personal perspective in your writing. Journal entries should be no longer than one (1) page double-spaced.

# **Article Review and Reflection (10 points)**

# Due: In class during 8 sessions

Students will select an article from a variety of article topics provided by the instructor that is related to human growth and development (excluding newspaper articles). This activity will take place during the beginning of eight of the class sessions. Three or four students will be responsible for presenting information and facilitating a reflective discussion with a small group of peers on a topic related to that evening's class topic. On the assigned night, students must bring 5 copies of a review sheet that they produced to share with their classmates in a small group. The small group will respond by discussing and completing a written reflection that is representative of the entire small group.

A sign-up form will be available for students to choose a night for their presentation.

# Research and Practice in Human Growth & Development: Brief Research Report (20 points)

DRAFT DUE: October 16th

FINAL Report DUE: October 30th

This assignment allows students to pursue a topic of their choice and conduct some basic research on the topic. This topic can be anything they are interested in that relates to the content of the course. Using the research skills demonstrated by the library session with Anne Driscoll (adrisco2@gmu.edu) and further discussion with the instructor, students are to find at least 3 scholarly, peer reviewed articles that cover their topic of interest that have been published in the past decade. They can and should incorporate older references, non-peer reviewed sources, or additional peer reviewed sources. The paper should include a literature review, synthesis, and reflection guided by the following questions: How is this information helpful for practitioners? Are there gaps in the knowledge? How does the student plan on using this information in the future? Students will use 12-point font, double-spaced and will not exceed 6 pages. Students are required to proofread their paper thoroughly and cite references according to APA, 6<sup>th</sup> edition.

# Field Experience Presentation/Report (25 points total) Field Experience Presentation: November 27th

Students will spend a significant portion of the semester observing and reflecting on their field experience. Since everyone's experience will be different, students can all learn from each other. Students will present their Field Experience to the class before the final paper is due. This is to help gather thoughts about the experience and make final touches to the paper based on feedback

from the class. Students may use PowerPoint or other materials to convey their presentation. This will be due and presented on **November 27**<sup>th</sup>. The exact time allotted per student for their presentation is TBD and will be based on the amount of students enrolled in the course. Students may also submit a **draft of your report** at this time for feedback from me. It is highly suggested that students take advantage of this, but it is not required.

# Field Experience Report: December 4th

Students will write a *Field Experience Report* based on a 10-hour field observation in a school/educational setting. Students should work through CEHD's field placement specialist at <a href="http://cehd.gmu.edu/endorse/ferf">http://cehd.gmu.edu/endorse/ferf</a> to register for placement. If there are additional questions that the students have they may email Lauren Clark, Field Placement Specialist at <a href="lclark@gmu.edu">lclark@gmu.edu</a> or <a href="mailto:fieldexp@gmu.edu">fieldexp@gmu.edu</a>. If there is a concern, students should see the instructor immediately. Students will submit a paragraph summary of what they plan to do for the observation by <a href="mailto:September 11th">September 11th</a>.

The final report should be one document that includes four sections:

- (1) a description of what was observed (lessons, activities, etc.), a description of the methods and materials used to meet the objectives of the lesson, and a description of how learning was assessed;
- (2) a description of the student needs (physical, emotional, social, intellectual) and how they were supported in the lesson, citing and integrating the theories/concepts of development discussed in the course;
- (3) a reflection of the field experience;
- (4) a completed field experience log signed by the teacher/supervisor (appended).

The full report should be submitted as one document in 12-point font, double-spaced. There is a 5-page limit.

#### **Inc-class Examination (20 points): December 11th**

A short-answer comprehensive final exam will be provided on December 11<sup>th</sup> and is due by the end of the class period that evening. The exam will cover readings and class discussion notes. The goal of this is not that there is one right or wrong answer, but to provide evidence that students can think critically about the content and integrate theories and concepts of human development, in the context of educational settings.

#### **Submission Protocol**

The standard submission, unless told otherwise, is through the Assignments section of the Blackboard. If there are any issues with this process, students should email the instructor with the assignment attached and in the meantime can resolve the Blackboard issue with the Mason tech team.
