Course Description

Provides opportunity for focused study on selected topics or emerging issues in special education and disability research. Course may not be applied to a degree program. Offered by School of Education. May be repeated within the term for a maximum 15 credits.

Course Overview

EDPD 506: Current Issues in Adapted Curriculum explores several, current best practices in teaching students with severe disabilities for licensed, practicing special education: adapted curriculum K-12 teachers.

Course Delivery Method

Learning activities include the following:

1. Class lecture and discussion
2. Application activities
3. Course readings and resources
4. Video and other media supports

This course will be delivered online (76% or more) using an asynchronous format via the Blackboard Learning Management system (LMS) housed in the MyMason portal. You will log in to the Blackboard (Bb) course site using your Mason email name (everything before @gmu.edu) and email password. The course site will be available on June 26.

Technical Requirements

To participate in this course, students will need to satisfy the following technical requirements:

Expectations

- **Course Week:**
Because asynchronous courses do not have a "fixed" meeting day, our week will start on Monday and finish on Sunday.
- **Log-in Frequency:**
Students must actively check the course Blackboard site and their GMU email for communications from the instructor, class discussions, and/or access to course materials at least 2 times per week.
- **Participation:**
Students are expected to actively engage in all course activities throughout the semester, which includes viewing all course materials, completing course activities and assignments, and participating in course discussions and group interactions.
- **Technical Competence:**
Students are expected to demonstrate competence in the use of all course technology. Students who are struggling with technical components of the course are expected to seek assistance from the instructor and/or College or University technical services.
- **Technical Issues:**
Students should anticipate some technical difficulties during the semester and should, therefore, budget their time accordingly. Late work will not be accepted based on individual technical issues.

- **Workload:**
Please be aware that this course is not self-paced. Students are expected to meet *specific deadlines* and *due dates* listed in the Class Schedule section of this syllabus. It is the student's responsibility to keep track of the weekly course schedule of topics, readings, activities and assignments due.
- **Instructor Support:**
Students may schedule a one-on-one meeting to discuss course requirements, content or other course-related issues. Those unable to come to a Mason campus can meet with the instructor via telephone or web conference. Students should email the instructor to schedule a one-on-one session, including their preferred meeting method and suggested dates/times.
- **Netiquette:**
The course environment is a collaborative space. Experience shows that even an innocent remark typed in the online environment can be misconstrued. Students must always re-read their responses carefully before posting them, so as others do not consider them as personal offenses. *Be positive in your approach with others and diplomatic in selecting your words.* Remember that you are not competing with classmates but sharing information and learning from others. - Identify and discuss strategies that support their own reflective practice as a special educator.
- Identify and discuss reading strategies to support students with severe disabilities.
- Identify and discuss math strategies to support students with severe disabilities.
- Identify and discuss strategies to support self-determination of individuals with challenging behavior.
- Identify and discuss strategies to support personal care and well-being for adolescent students with severe disabilities.

Required Texts

Course readings will be posted on Blackboard. Additional, supplemental materials will be provided to students.

Course Performance Evaluation

Students are expected to submit all assignments on time in the manner outlined by the instructor (e.g., Blackboard, VIA, hard copy).

Assignments and/or Examinations

Course Activities: Students are expected to complete course activities for each module. Module activities include viewing the recorded lecture, reading provided course materials, and engaging in module discussions and other module activities.

Module 1 Discussion Board: Students are required to complete the discussion board assignment located in Module 1. Directions for the discussion board are posted on Blackboard. It is recommended that students complete the discussion board assignment by 7/2, but students must complete the assignment by 7/30 to be considered for credit.

Module Quizzes: Students are required to complete 4 quizzes within Modules 2-5 by 7/30. Students will have two opportunities to complete each quiz, with the highest score counting. Students must score at least 70% on each quiz for a satisfactory grade. Quizzes are open note, meaning students may access course resources while completing each quiz.

Students are expected to exhibit professional behaviors and dispositions at all times. Professional dispositions are an essential function of a special educator’s job, indicating that these dispositions are critical to develop and assess in special education licensure programs. In the College of Education and Human Development, dispositions are formally and separately evaluated in at least three points in each student’s program – a self-evaluation at the start of their program, a self-evaluation at the mid-point of their program, and a university supervisor’s evaluation during internship. In special education graduate licensure programs, the initial self-evaluation is completed in a designated course (EDSE 501), the mid-point self-evaluation is completed in designated courses (EDSE 627, EDSE 661, and EDSE 616), and the internship evaluation is completed by instructors in EDSE 783, EDSE 784, and EDSE 785. In addition to these three designated evaluation times, instructors may complete instructor-rated disposition assessments other times throughout the

program. When dispositions are assessed, it is important that for areas where a positive disposition is rated as “not proficient,” the student takes steps to grow as an educator. See <https://cehd.gmu.edu/epo/candidate-dispositions>.
